# The Peter F. Geolot Educational Foundation Continuing Education Career Enrichment Grants

#### **ELIGIBILITY REQUIREMENTS**

- 1. This program is not intended to provide assistance in paying for courses in a degree program in a college or university. Please do not apply if you do not meet this criteria.
- 2. This program is intended to assist members of the Order with their career development by supporting members who wish to enroll in continuing education courses in job related fields, or for enrollment in continuing education courses in a new field to further their occupational goals. Grant funds will be awarded as an incentive for individual growth and development.
- 3. The grant application should be made at least 60 days before the grant funds are required.
- 4. Grant applicants must be member of a branch of the Independent Order of Odd Fellows.
- 5. Eligible expenses:
  - a. Required books/publications for continuing education courses
  - b. Tuition and student fees for continuing education courses
- 6. Individuals may apply for up to \$1,500.00. Do not include costs that may be covered by your employer or someone else.
- 7. Grant program policy, guidelines and budget will be set by The Educational Foundation, IOOF Board of Trustees.
- 8. Recipients of Continuing Education Grants will submit a 100-150 word signed article for The IOOF News about the class they attended. The article should include a review of the class, highlights of what was learned and how it will be useful on the job. The article is subject to editing by The Educational Foundation, IOOF staff and will be published by the Sovereign Grand Lodge as space allows.
- 9. Grant applications will be reviewed by The Educational Foundation, IOOF Executive Committee and awarded on a competitive basis. Award decisions will be based on the amount of funds available and the total of applications received and past grant(s) received by applicant(s). Possible results of application review are:
  - 1. Award full amount requested
  - 2. Award less that full amount requested
  - 3. Deny application
- 10. Grant applications for continuing education programs at an accredited college or trade school will be reviewed, and if approved, funds will be provided prior to matriculation in the course(s).
- 11. Applicants must obtain a certification on their application that they are members in good standing of an Odd Fellow or Rebekah Lodge. Membership in the Order does not constitute automatic qualification for grant funds.
- 12. Applicants will be notified in writing of the action taken on their application.
